Above the Fold: What has the township done now!

The township has accomplished much over the past year, and seemingly, residents have approved of the progress. The Board of Trustees has looked at a wide range of issues, so let's see what has been done over the past twelve months with the help of many volunteers and funding from the Women's Auxiliary.

Capital Improvements

(repairs, alterations, and replacement):

- Old fire hall (pump house next door to the current fire hall). Volunteers removed debris to make space for summer storage of the tractor and winter storage of the wildfire tanker.
- Roadside improvement. Funds from the State were used to replace the collapsing fence along Lake Street, to install a township sign near the office, and to

put up a Gay history interpretative sign at the park site.

- Township Office. Upgrades included a new computer for the Clerk, replacement laser fax/printer, and Internet cabling. A volunteer repainted the entrance doors and front porch.
- Community Hall. A contractor replaced windows on the main floor. A local workman replaced a basement door, improved drainage around that door, and installed hardwood flooring over a floor vent. Volunteers installed smoke alarms to comply with insurance requirements, re-routed a basement light switch to the entrance door, and repainted benches.
- Water Supply Plant. Five supply-line valves between the main and houses were replaced. The old treatment

plant was sold by auction with money (\$22,551) going to the water plant account. Volunteers installed a fence to protect the water storage tank. They also made improvement in plant room, adding a dehumidifier, stainless steel lab counters, chlorination system, phone and Internet lines, computer and printer for electronic record keeping, smoke alarm, and floor repainting.

Township Policy Updates
(the governing issues and requirements):

- State law and regulations required the township to adopt many procedural improvements, including a credit card usage policy, township bylaws, a township policies manual, and Freedom of Information Act polices.

took the oath of office at the December 13, 2012 board meeting with their first official act as the new board being the initial development of the 2013-2014 budgets and selection of the 2013-2014 Board of Review members.

911 Emergency Call Box installed at Fire Hall!



The Keweenaw County 911 Commission funded the purchase of 911 emergency call boxes for selected locations in the County, where cell phone coverage is limited or unavailable. Gay was selected as one of these locations. An emergency call box would provide a way to contact emergency services, using a phone line directly connected to the regional 911 call center.

Emergency call boxes have the advantage that their location is immediately

known by the 911 call center. Mobile phone users in trouble do not necessarily know where they are, which can cause delays in getting emergency services.

The emergency call box, installed by the Fire Chief, is located on the front of the Fire Hall in plain sight of traffic passing by the township buildings on Second Street in Gay. The emergency call box will provide 911 emergency services for local residents or those traveling in the area, including motor-

ists, bicyclists, ATVs, and snowmobiles.



DNR awards Sherman Township a \$24,600 grant!

Congratulations to all who helped work on the grant application and subsequent revisions. The township's Recreation Board members were responsible for overseeing the application process, and they worked many hours in making this a success.

Sherman Township was one of only 19 applicants to be approved for the Michigan Department of Natural Resources Passport Grant funding for 2013. More than 80 applications were submitted from townships, villages, cities and counties all across the state. Although the grant was less than the \$29,500 requested in the application, the funding should meet the goals of the project.

The township started the grant application process a year ago for developing a new park in Gay. After many revisions and comple-



tion of the numerous documents required in the application package, the grant application was approved by the Board of Trustees and submitted before the April 2, 2012 submission deadline.

The grant and required local match, \$10,000, will finance the facilities improvement project next to the historic Gay school. The project entails the construction of designated parking areas, a pavilion with tables, grills, and a water fountain, and a screened area for portable toilets, available in the summer. The park has been designed for universal accessibility.

MI DNR Recreation Passport Grants

Public Act 32 of 2010 created the Local Public Recreation Facilities Fund for the development of public recreation facilities by local units of government.

This money comes from sale of the Recreation Passport, which replaces the resident Motor Vehicle Permit - or window sticker - for state park entrance. The passport is required for entry to state parks, recreation areas and boating access sites.

The first \$12,730,000 of the fund replaces lost revenue from the elimination of the motor vehicle permit and boating access site permits, as well as to pay for administration by the Secretary of State. Ten percent of remaining revenue is used to fund the Recreation Passport local grant program. - Lacking standard operating procedures for several township responsibilities, the Board of Trustees also adopted water use billing policies, a Capital Improvement Plan, and a Land Division Ordinance.
- The board established a Recreation Board, Freedom of Information Act Coordinator, Receiving Board for elections, and Grounds Maintenance position for mowing and snow removal.

Financial Progress (looking for ways to save money):

- The Board of Trustees bid a contract to ensure the lowest cost for insurance, reducing the cost by over \$3,000 per year.
- The township treasurer worked with a local bank to reduce or eliminate bank fees on accounts.
- The township stopped supporting dumpsters in Gay and coordinated local residential refuse pickup, eliminating the escalating costs of dumpsters and

reducing per capita costs to residents.

- The township sold the abandoned water treatment plant, reducing property and liability insurance costs.

We hope that you agree that this has been a productive year. We are always looking for input from residents, seasonal and permanent, and invite you to the Board of Trustees meetings, the second Thursday of each month at the Township Office.
