TO THE QUALIFIED ELECTORS:

Residents of Keweenaw County: PLEASE TAKE NOTICE that any qualified elector who is not already registered, may register to vote at the office of the appropriate Township Clerk; the Office of the County Clerk; a Secretary of State branch office or other designated state agency. Registration forms can be obtained at www.mi.gov/vote and mailed to the Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the Township Clerk is **Monday, July 20, 2026**.

After that date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following:
