Notice is hereby given that a Primary Election will be held in Keweenaw County on **TUESDAY, AUGUST 4, 2026**

RACES	Governor, U.S. Senator, Representative in Congress, State Senator, State Representative, Road Commissioner, Delegates to County Conventions, Sherman Township Clerk
COUNTY PROPOSAL	Renewal County Allocation to establish separate tax limitation millage rates for a period of 4 years
TOWNSHIP PROPOSALS	ALLOUEZ TOWNSHIP-Renewal of 2 mills from 2026 to 2033 for fire protection, medical first responder services, fire hall, vehicles, equipment, hydrant system and supplies raising an estimated \$118,205 in the first year EAGLE HARBOR TOWNSHIP-Renewal of 1 mill from 2026 to 2030 for emergency services including fire protection and medical first responders raising an estimated \$64,609 in the first year HOUGHTON TOWNSHIP-Renewal of 3 mills from 2027 to 2030 for operational expenses raising an estimated \$59,355 in the first year
SCHOOL BOND PROPOSAL	CLK PUBLIC SCHOOLS-Borrow \$21,850,000 and issue general obligation tax bonds for remodeling, including replacement and upgrade of heating systems, air handling and ventilation systems, building infrastructure improvements, exterior windows; acquiring instructional technology equipment for school buildings; and developing a parking area and site
