TO THE QUALIFIED ELECTORS:

Residents of Keweenaw County: PLEASE TAKE NOTICE that any qualified elector who is not already registered, may register to vote at the office of the appropriate Township Clerk; the Office of the County Clerk; a Secretary of State branch office or other designated state agency. Registration forms can be obtained at michigan.gov/vote and mailed to the Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the Township Clerk is **Monday, October 19, 2026**. After that date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following:

STATE: Proposal to convene a Constitutional Convention for purpose of drafting a general revision to the State Constitution

STATE: Proposal initiated law to prohibit campaign contributions from certain regulated utilities and government contractors and apply campaign finance laws and regulations to additional types of political communications

CCISD: Proposal to replace millage that expires in 2026 with increase by .2903 mill for a period of 20 years, 2027-2046 to provide funds for the education of students with a disability with approximately \$601,033 to be collected in the first year
